It is notified for the information to all concerned that the eligible students (At least 60% marks in Last Qualifying Examination (combining both Semester - I & Semester-II / Semester - III & Semester-IV) of Four/Three Year B.A./B.Sc./B.Com. 3<sup>rd</sup> and 5<sup>th</sup> Semester courses (under CCF) should apply for "Swami Vivekananda Merit- cum- Means Scholarship- 1<sup>st</sup> / 2<sup>nd</sup> RENEWAL" (Non-minority) through the website : <https://svmcm.wb.gov.in/>.

It is to be noted that -All Semester Examinations need to be cleared in the first attempt and no application will be forwarded by the institution if semester were cleared in subsequent supplementary examinations. Students who have not applied for 1<sup>st</sup> RENEWAL due to inadequate marks (<60%) are not eligible for 2<sup>nd</sup> RENEWAL even if they obtained at least 60% marks (Combining Semester - III & Semester-IV).

It is to be noted that they have to upload the marksheets of the both Semester-I & Semester-II/ Semester-III & Semester-IV (both sides) and Utilization Certificate.

They must submit the hardcopy of the application form along with all relevant documents at the college office from 12 noon to 3 P.M. on & from 09/02/2026 on all working days (except CU Examination day & holiday).



### The documents that have to be submitted:

1. Print out of duly filled up scholarship application form.
2. Mark sheet of Last Examinations (Semester-I & Semester-II/ Semester-III & Semester-IV) (Photocopy).
3. Receipt of recent Admission/ Enrollment to next Semester (Semester-III/ Semester-V).
4. Properly signed Utilization Certificate.
5. Photocopy of Bank Passbook (1st Page containing A/C number, IFSC Code and Beneficiary Name) and the page which shown the receipt of previously sanctioned SVMCM scholarship amount.

**\*\*\*\*Students have to show original Marksheets of Last Examinations (Semester-I & Semester-II/ Semester-III & Semester-IV) during submission at the office for verification regarding passed in first attempt (No supplementary) & Percentage of marks.**

**\*\*\*\* For signature of the HOI in the Utilization Certificate, students have to submit details of expenditure of the last sanctioned SVMCM scholarship amounts.**

Renewal cases (concentrated only at a particular level of study) will be sanctioned subject to good academic performance (Minimum 60% marks should be obtained from Higher Secondary Level to Undergraduate Level (combining both semester) at the promotional examination).
